

PEP725 Data Use Policy

All data and information collated by PEP725 are made available online with as few restrictions as possible, on a nondiscriminatory basis.

The PEP725 project management team, as operators of the website, requires all Database Users who have access to the PEP725 data to abide by the following terms and conditions of this policy document.

Terms of PEP725 Data Use Policy

- 1) *Acceptable use.* PEP725 Database will be open and universally available for the purpose of academic, research, educational, government, recreational, or other not-for-profit professional use. The Database User is permitted to produce and distribute derived works from this Database provided that they are released under the same license terms as those accompanying this Database. Any other use of the data or its derived products will require explicit permission from the Owner(s) of the Data Set(s).
- 2) *Redistribution.* It is strictly forbidden to redistribute PEP725 Datasets, or any part of the datasets, without written permission of the PEP725 project management or the Data Owner.
- 3) *Responsibility:* Neither PEP725 project management nor PEP725 project members and partners, are responsible for database content or the use of the data
- 4) *Liability:* Neither PEP725 project management nor PEP725 project members and partners, are liable for the content of database, or for any loss, damage, claim, cost or expense, however it may arise, from an inability to use the PEP725 Database and Website

- A Statement of Intended Use that is compliant with the above agreements. Such statements may be submitted via the data access portal interface.
